


THE CAPTAIN PROPERTY – OUR FOCUS IN 2012

- The Captain Property is 100% owned and 417 square kilometres in size, located approximately 65 kilometres northeast of Fort St. James, British Columbia.
- The property is bordered by Xstrata Resources to the south and west, Gold Fields to the west, and Thompson Creek Metals to the north.
- The property hosts a large copper/gold porphyry system measuring over 7 x 7 kilometres.
- Orestone's first round of drilling completed in January 2012 intercepted porphyry-style mineralization grading near Mt. Milligan ore grades.
- The geophysical and geological characteristics of the Captain Project are similar to the Mt. Milligan Deposit (proven and probable reserves 482 Mt at 0.20 Cu% and 0.39 Au g/t; Terrane Metals Corp. NI 43-101 Technical Report October 2009), located 30 kilometres to the north.



The primary goal for Phase I exploration was to establish the existence of a large mineralized copper/gold porphyry system which has been accomplished. Phase I exploration, budgeted at \$600,000 consisted of grid layout and 31 line kilometres of geophysics (Induced Polarization, Resistivity and Ground Magnetometer), 1240 metres of core drilling in four-holes and petrographic studies of the drill core material.

THE CAPTAIN PROJECT IS LOCATED APPROX. 30 KM SOUTH OF THE MT. MILLIGAN MINE, WHICH IS EXPECTED TO BEGIN PRODUCING COPPER AND GOLD IN 2013.









Assays from hole C11-01 returned an intercept of 87 metres from 127 metres grading 0.230 g/t gold and 0.03% copper, including 43 metres grading 0.298 g/t gold and 0.09% copper and 16 metres grading 0.434 g/t gold and 0.133% copper.



The primary goal for Phase II exploration in 2012 is to confirm economic grades of copper/gold and begin to outline the East target as well as conduct initial test drilling on a second target. Phase II exploration is budgeted at \$650,000 to \$1.2 million consisting of 10 line kilometres of geophysics, 2,000 to 4,000 metres of core drilling in 10 to 20 holes and petrographic studies of the drill core material.
